- **Recycling and Waste Reduction**: Partnering with suppliers to recycle uniforms, spent bait and office consumables and minimise waste across our operations.
- Net Zero Commitment: Our commitment to achieving net zero emissions by 2050 is aligned with the Climate Change Act 2008 (amended 2019) and the Environment Act 2021. Detailed steps are outlined in our Environmental Policy, which provides further guidance on how we monitor, track, and reduce our carbon footprint. This includes the use of specific carbon tracking tools and milestones for achieving intermediate targets, such as a 2030 reduction goal.
- **Sustainable Procurement**: Committing to selecting environmentally responsible suppliers and utilising eco-friendly materials wherever possible to reduce the environmental impact of our operations.
